
COUNT ONE

**Alien in Possession of Firearm  
(18 U.S.C. §§ 922(g)(5)(A), 924(a)(2))**

On or about November 12, 2001, the defendant, **Abel GERMAN-German**, a native and citizen of Mexico not legally present in the United States, knowingly possessed a firearm, that is: a Norinco NHM 90/91 rifle, caliber 7.62X39 mm, serial number 9463094, which had been shipped or transported in and thereby affected interstate or foreign commerce, in violation of Title 18, United States Code, Sections 922(g)(5)(A) and 924(a)(2).


